
At the recent meeting of the Bailies' Council, it was decided to ask your advice on the design of a tie and headscarf.

As you see, the headed notepaper has the outline of the Bennachie range as its heading. The eastmost peak, known as the Mither Tap is the most distinct top, and it should be incorporated into the design. I enclose a postcard and three slides, showing the outline of the Mither Tap, with the 'bump' on its right side - which is known as the Nether Maiden. If the outline could be slightly exaggerated, it would probably look better. The colours on the slide marked with a * would reflect the hill colour.

The decision whether to have a single below knot, with the design inside, or the outline alone, with the words 'BAILIES OF BENNACHIE' round the edge, or below as appropriate was not definitely decided upon until designs were seen.

I return the sample tie with thanks for allowing it to be retained so long.




Thankyou for your letter of 11th December, and I apologise for not contacting you earlier, The Council of the Bailies met last month and decided to order ties with a single below knot motif.
